<u>IN THE MATTER OF RESOLUTION (R-73-2013) OPPOSING HOUSE BILL (HB) 59 REGARDING COUNTY RECORDERS</u> <u>EQUIPMENT FUND</u>

WHEREAS, as reported last week, HB 59, as passed by the House, retains language that alters the nature of the county recorder's equipment fund from a permissive special fund, approved by the board of the county commissioners, to a mandatory fund upon the request of the recorder; and

WHEREAS, in addition, the language provides that any funding received under the technology proposal "does not diminish the duty of the Board of County Commissioners to provide funding for the expenses incurred by, and the personnel necessary for the county recorder to perform the duties of office;" and

WHEREAS, the Board of Commissioners have determined that the County Commissioners Association of Ohio (CCAO) strongly opposes this abrogation of commissioners' budget and appropriating authority; the Board of County Commissioners represents the appropriate discretion for making such appropriations; and

WHEREAS, as the duly elected budget authority for counties, the Commissioners are entrusted with ensuring not only the efficient use of taxpayer dollars, but also that the use of dollars represents the proper prioritization of limited county resources.

<u>IN THE MATTER OF ADDENDUM TO OHIO DEPARTMENT OF REHABILITATION AND CORRECTION PROBATION IMPROVEMENT AND INCENTIVE FUNDING</u>

Upon request from the Darke County Common Pleas Court Judge, Mr. Rhoades moved to approve the signing of the 'Addendum'; motion seconded by Mrs. Delaplane and all voted YEA.

This Addendum is between the State of Ohio, Department of Rehabilitation and Correction, and **Darke County.** It modifies the <u>Probation Improvement and Incentive</u> subsidy grant agreement in the amount of <u>\$180,648</u> executed by the parties on the date of <u>January 3rd</u>, <u>2012</u>.

The Darke County grant (grantee) has achieved an Incentive Award as described in Section E of the Probation Improvement and Incentive grant agreement. The Department of Rehabilitation and Correction has reviewed the performance goals and determined that the grantee will be awarded an incentive award in the sum of \$23,127\$. The grantee may use this award for any community corrections program/service as defined by ORC 5149.30 (A). The grantee shall expend these funds on a community corrections program/service before June 30th, 2015. The incentive award expenditures shall be separate from any expenditure in the Probation Improvement and Incentive grant total. The grantee will provide to the grantor a written list of the items/services purchased when the funds have been exhausted or by July 30, 2015.

The Darke County grant will be renewed in Fiscal Year 2014 and Fiscal year 2015. The grantee will be awarded <u>\$75,000</u> in advance of the 2014 Fiscal Year. These funds shall be expended during the Fiscal Year 2014/2015 grant period and shall not be expended until after July 1, 2013.

The grant award shall be increased by <u>\$98,127</u> from <u>\$180,648</u> to <u>\$278,775</u> effective on the date approved by the Deputy Director of Parole and Community Services of the Ohio Department of Rehabilitation and Correction.

The installments will be paid in the following manner:

- (a) FY12 Two Payments \$45,162 totaling \$90,324.
- (b) FY13 Four Payments of \$22,581 totaling \$90,324.
- (c) FY13 One Payment of \$98,127 totaling \$98,127. This payment includes \$23,127 for the incentive award and the \$75,000 advance for FY14/15.

Total expenditures for the FY12/13 grant period (January 1, 2012 to June 30, 2013) will not in any case exceed \$180,648.

His fluency in Arabic, French, and Hungarian, has served him well. He joined the U.S. Foreign Service as Vice Consul, U.S. Embassy, Port-au-Prince, Haiti (1986-1987). He then went to Budapest, Hungary (1988-1991) and served during a period of great change for that country, and then moved on to serving Deputy Secretary of State Lawrence Eagleburger, focusing on assistance programs for the United States of America in the countries of Central & Eastern Europe; and

WHEREAS, he also served at U.S. Missions in Israel, Tunisia, Iraq, and Lebanon. He most recently served as Assistant Secretary of State for Near East Affairs with the rank of Senior Career Minister.
