### **James C. Boland**

***Retired Vice Chairman, Ernst & Young***

***Former President, CEO & Vice Chairman, Cavaliers Operating Company***

Mr. Boland served as President and Chief Executive Officer of Cavs/Gund Arena Company, the Cleveland Cavaliers professional basketball team and Gund Arena, and Vice Chairman of the Cavaliers Operating Company, LLC. Mr. Boland was a partner of Ernst & Young LLP for 22 years, serving as Vice Chairman and Regional Managing Partner and Vice Chairman of National Accounts. Mr. Boland is also a Director of The Sherwin-Williams Co., The Goodyear Tire & Rubber Co. and Invacare Corp., and was a Director, from 2004 to 2005, of International Steel Group. ### **Steven A. Davis**

Before joining Bob Evans in 2006, Mr. Davis worked at Yum! Brands Inc. as president of Long John Silver's and A & W All-American Food Restaurants. He held a variety of operations management and executive positions at Pizza Hut and was with Kraft General Foods for nine years, his last position being director of marketing for All American Gourmet. Mr. Davis is a board member of the Arthur G. James Cancer Hospital and Richard J. Solove Research Institute Foundation; a member of the Columbus Partnership and Compete Columbus; and in 2007 was chair of Operation Feed in Central Ohio. *Black Enterprise Magazine* in 2005 named Mr. Davis one of the 75 Most Powerful Black Men in American Business.

### **E. Gordon Gee**

One of the most highly experienced and respected university presidents in the nation, Dr. Gee returned to The Ohio State University in 2007 after serving as Chancellor of Vanderbilt University for seven years. Dr. Gee holds a law degree and a doctoral degree in education from Columbia University and has been awarded a number of honorary degrees. He is a member of the Business-Higher Education Forum and the Columbus Partnership. In 2009 Time Magazine named Dr. Gee the best college president in the country.

Dr. Harris is the chief information officer and chairman of the Information Technology Division of Cleveland Clinic.
