43rd Annual DARKE COUNTY ENGINEER'S ANNUAL REPORT FOR 2020

This report shows money received for the year, where it was spent, and what it maintained, constructed, purchased, or improved. We always try to maximize the funds spent on road and bridge improvements. For 2020, not including a paving grant, this was \$3,111,934.56, or an amount equal to 42.1 percent of our total annual receipts. The recent Ohio fuel tax increase has greatly helped our cause, as the receipts increased 23% over 2019, while our annual cost of diesel fuel and gasoline was down 38% from that of 2019.

In spite of the challenges and limitations forced by the pandemic, we managed to resurfaced 30.92 miles of County roads by contract, applied chip-seal/fog seal surfaces to 25.25 miles with County personnel and equipment, construct two new bridges, complete eleven bridge rehabilitation and repair projects, and all of the many tasks necessary to maintain our large inventory of roads and bridges. We also never missed a work day.

Later in the year we began construction of a new truck storage/office facility which will be completed before mid-2021. This was imperative since we have simply outgrown our building constructed in 1977-78.

Our employees continue to perform all road and bridge construction and maintenance work, with the only exceptions being asphalt paving and road striping. Crews perform all surface sealing, snow/ice control, roadside mowing, and sign erection and maintenance, on 522.575 road miles. They also performed tree trimming and removal, replaced 31 culverts on County and Township roads, and made numerous ditch and drainage improvements.

Total spending for 2020 was \$1,235,899.04 (21%) greater than 2019, but \$288,463.59 (4%) less than the total year's receipts.

2020 ROAD IMPROVEMENTS

We contracted asphalt resurfacing with Walls Brothers Asphalt on eleven different roads totaling 22.14 miles for \$1,771,562.93. Also, using County personnel and equipment, we applied chip seal and fog seal to 25.25 miles of fifteen different roads with a material cost of \$262,719.22. The per-mile cost difference between the two applications is over 7 to 1, and both methods are used to preserve and improve the surfaces of 40-50 miles of road per year with available revenues.

An additional 8.78 miles was resurfaced of the entire Gettysburg-Pitsburg Road through a CSTP project with 80% federal participation in the costs. This was after extensive shoulder widening performed in 2019, and replacing a deficient bridge in early 2020, all with County forces.

A total of 56.17 miles of County road received new surfaces in 2020, which is 11% of the total mileage (522.575). If this rate can be continued, all roads could have surfaces renewed every 9-10 years.

Total County paving and sealing costs: \$2,956,955.11 (with \$738,138.37 paid by federal funds).

PAVEMENT MARKINGS

We contracted the painting of new centerline/no-passing markings on 203 miles of County road, and white edge lines on 603 lane miles (301.5 road miles) through Aero-mark Inc. The total cost was \$257,291.72, using 13,263 gallons of paint and 53 tons of reflective glass beads. The average cost was \$340 per road mile for yellow markings and \$625 per road mile for white edge lines. We also coordinated the application of 69.7 miles of centerline and edge-line markings for ten different Townships and the Village of Rossburg at a contracted cost of \$27,294.97.

TOWNSHIP COOPERATIVE WORK

During 2020, the highway department provided \$24,385 of free labor and equipment to 15 Boards of Township Trustees, and \$18,500 to 4 Townships that was reimbursed. This work included the replacement of 27 roadway culverts (12"-48" diameter) on 7 different roads in 6 different Townships. The Trustees of two Townships (Neave and Wabash) each furnished new asphalt surfaces for a rehabilitated bridge on their roads during the year.

We also supplied the specifications and bidding process for the asphalt paving of seven different Township roads in seven different Townships, totaling 7.723 miles.

OTHER PROJECTS

We applied and received grants of \$51,595.00 to upgrade and improve selected warning, curve, and road name signs throughout the county, which were all erected by County labor and equipment. Also, 2346 feet of 18 inch diameter "County" tile was relocated off County road right-of-way at a cost of \$19,424.88.

2020 BRIDGE CONSTRUCTION AND REHABILITATION

In addition to maintenance and repair, we built two new bridges on County roads, and rehabilitated two more with data shown below. All design and construction for the bridge projects shown below was by County personnel, and all funding for these projects was 100% local.

NEW BRIDGES (2)

Both new bridges were galvanized steel beam superstructures with timber decks on new concrete abutments. All bridge work, including steel fabrication was done by Darke County personnel.

Costs shown include additions for overhead on labor and materials as mandated by Ohio law and the State Auditor's policies for force account bridges built after 07/01/2003.

BRIDGE REHABILITATIONS AND REPAIR (11)

On the two rehabilitated bridges on Cohn and Byrket Roads, the steel was reconditioned and new timber decks were installed with waterproofing and new asphalt surfaces furnished by the Township Trustees.

A contract was awarded in December to Brumbaugh Construction Inc. for the 2021 construction of a new replacement bridge on Fisher-Dangler Road (T092-01.91) over Greenville Creek, with a 100' span and 28' width truss structure. The expected cost will be \$882,592.00 with 80% of funding coming from federal bridge funds. Also in 2019, \$12,528 was spent for subsurface investigations and \$5,428 for foundation design for this new bridge.

432 new bridges have been built on Darke County and Township Roads since 1977.

Maintaining roads and bridges involves many different tasks and responsibilities. The most visible are snow plowing and roadside mowing, but the continual repair and replacement of signs, maintaining drainage along and through the roads, repairs from weather events and vehicular accidents, and the trimming and removal of trees and brush along roads are never-ending tasks. Repairing and sealing cracks in asphalt pavement surfaces to prevent water intrusion is continuous. Our team chip-seals roads, builds new bridges, maintains and repairs existing bridges and culverts, inspects all bridges, maintains and repairs roads, and maintains and repairs all County equipment. They perform all types of road and bridge work with the exceptions of asphalt road resurfacing and the painting of the yellow and white lines on the pavement.

The department includes the County Engineer and thirty-one personnel, with twenty-seven at the Highway Department and four at the Courthouse Office. The office performs surveying and design, all bridge inspections, contract management, clerical and payroll, maintains tax maps, and checks and approves all deed transfers and new surveys.

Our most difficult challenge continues to be the maintenance of 522.575 miles of asphalt road surfaces, the integrity of 517 bridges, and to improve the system with available revenue in the face of ever-rising costs.
